## **Step 1: Complete and Submit Application**

**Complete the application in full and attach the following documents:**

- Current Resume
- Copy of High School Diploma, GED, or College Degree
- Copy of your National Registry certification and/or current state EMS license at the level for which you are applying
- Copy of your BLS card (all levels), ACLS, and PALS cards (paramedic only)
- Additional certifications such as NRP, ABLS, PHTLS, and AMLS are encouraged but not required
- **Include all required signatures – double-check your application before submitting**

## Step 2: Online Exam

A link will be e-mailed to selected applicants at the email address you provided in your application. This test covers material similar to the NREMT cognitive exam.

## Step 3: In-Person Interview

Top-scoring candidates will be invited via email to attend an in-person interview at our Administrative Building, 6116 Graye Lane, Caldwell, ID 83607.

## Step 4: Physical Agility Test

Successful candidates will be invited to complete a Physical Agility Test (PAT). Internal candidates who have completed the PAT in the past 12 months will not need to re-take the PAT.

## Conditional Offer

Successful candidates may be given a conditional job offer contingent upon passing all of the below:

- Physical Agility Test
- Pre-employment physical exam
- Pre-employment drug screen
- Background check

## Orientation
