## Step 2: Online Exam

## Step 3: In-Person Interview

Top-scoring candidates will be invited via email to attend an in-person interview and physical agility test (PAT) at our Administration Building, 6116 Graye Ln, Caldwell, ID 83607 the week of April 6<sup>th</sup>.

## Step 4: Conditional Offer

Successful candidates may be given a conditional offer of employment contingent upon passing the following:
